Cinema Society April 2, 2020 showing postponed to Oct. 29, 2020; Season renewal and other important information

As you all likely know by now, the Coronavirus crisis has caused closures and cancellations of nearly everything at this time, including the postponement of Cinema Society of PebbleCreek's season finale film, Streaker, that was scheduled for April 2, 2020. We are pleased to announce that **we have rescheduled the showing for all members of this season's Cinema Society of PebbleCreek on Oct. 29 at 10 a.m. in the Renaissance Theater.** So those people who are members right now (2020-2021 season) who would like to attend the new date certainly can, just arrive as you always do, with your member badge in hand. We selected this date as close to the start date of the new season as we could, in light of availability of our Theater and Andy's schedule, in hopes that we have as many community members in town as possible.

## **Refund option:**

For those who cannot attend on Oct. 29, we will offer a refund option of a check for \$20.83 per membership, for any member who requests it, and does the following:

- **Send an email to [patricia.wegehaupt@robson.com](mailto:patricia.wegehaupt@robson.com) requesting your refund no later than May 1, 2020. Please put CINEMA REFUND REQUEST in the subject line.**
  - Include your name, address (where you want the check mailed), badge number and names of anyone else in your household who is also a member requesting a refund.

- **Temporarily return your membership badge(s) by dropping off to the Activities Office, (via the mail slot if operations are still limited) in a sealed clear plastic bag clearly marked on the outside with your name and badge number(s), no later than May 1, 2020.**
  - We will begin redistribution of these badges to renewing members beginning at 9 a.m., Friday, Oct. 30, 2020, and through the beginning of the Nov. 19 first showing (or later if needed), we will sticker these with the new season 2020-20201 sticker and you will be ready to go for the new season.

### **Rules-exempt VIP guest ticket**

As a one-time opportunity, once we know if/how many refunds are requested, we can make that number of spots open for 2019-2020 members to purchase as special rules-exempt VIP guest tickets that ANYONE in the community can use. This is a great time for a friend, neighbor or spouse who has been wanting to experience Cinema, but not ready to become a member to see what we all have been enjoying every year. These special VIP guest tickets will be \$21. On Monday, May 4, we will notify members of the 2019-2020 season how many tickets are available and they will go on sale, Wednesday, May 6, to 2019-2020 season members only, initially. Depending on how many are available, we will also announce any purchase limits on May 4. If extra tickets are available after May 6, we may open up VIP guest ticket sales to non-member residents.

### **Renewals**

Renewals for existing members will go on sale Tuesday, Sept. 8, at 9 a.m. in the Activities Office, cash or check only made out to PCHOA. Your spot is guaranteed to be held until Sept. 25, 2020. So please make renewal arrangements by this date

### **New memberships**

Any seats remaining open for new members will go on sale Thursday, Oct. 1, at 9 a.m. in the Activities Office, cash or check only made out to PCHOA.
