Coronavirus Update - 3/26/21 - About the Governor's Order of March 25, 2021

Sunday, March 28, 2021

The Governor's Order of March 25, 2021, transitions what were previously "Requirements" to "Recommendations". The Order directs businesses to continue following the recommendations of the CDC, ADHS and other public health officials. The guidance of those officials continues to set the standard for HOA Policy decision-making. <u>Click here to read</u> the Governor's Executive Order.

With that guidance in mind, we would like to share the following information. As we review opportunities, begin to clean and sanitize additional areas, hire additional staff and evaluate the community needs and the feedback of residents as a whole, we are requiring masks in certain areas and have loosened restrictions in some other areas, like Fitness Centers and all outdoor activities. We will reevaluate in a few weeks and offer updates.

All HOA Staff is still required to wear a mask to protect homeowners, guests and fellow staff until further notice. Please note mask usage is still required when approaching an HOA Staff member or visiting an HOA Office.

Fitness Centers

Effective Monday, March 29, 2021, masks can be removed while actively exercising and remaining socially distanced. Capacity limits will remain in place. Masks are still required for entering, exiting and moving around the building.

On Monday, March 29, 2021, we will be opening Locker Rooms, Showers, Saunas and Steam

Rooms, asking that you maintain social distance at all times. Avoid congregating for conversations in the exercise areas. No masks are needed when in the sauna and steam rooms.

Pools

We have put out additional chairs on the pool decks, thus increasing capacity. Masks are required upon entering and when moving around the facility. No mask needed when seated in the pool chairs or in the pool/spa water itself.

On April 1, we will begin to take reservations for use of the Oasis Pool Ramada on or after April 5, 2021. Contact the Activities Offices for reservations at 623-535-9854.

Outdoor Sports Activities

Mask use is not required while engaging in any outdoor sporting activities. It is up to each individual sports club to set any more restrictive guidelines for their club's specific activities.

Clubhouses

Masks required when moving around the common areas of the buildings and approaching service desks.

Meeting Rooms

As a reminder, beginning April 5, some meeting rooms are reopening. Masks are recommended, but usage is at the discretion of the group using any given meeting room. Furniture in the meeting rooms has been placed for social distance; please do not move the furniture at any time. For questions regarding meeting rooms, contact the Activities Office at 623-535-9854. No banquet service is available for meeting rooms at this time.

Golf Shops

Masks and social distance required when entering the Golf Shops.

Restaurants

Masks required when entering/exiting/moving around the building. Masks may be removed once seated at a table.

Your HOA Board and management staff will continue to evaluate opportunities, and we do anticipate further loosening of mask requirements and capacity restrictions in the coming weeks. We will continue to keep the community informed as changes are made.
