Status of Activities Office events through the end of April 2020

As you know, the PebbleCreek HOA has taken unprecedented action to help stop and slow the spread of COVID-19 by closing our Facilities through March 31, as well as canceling all large events until further notice. Please note that if you have questions about the status of any event, you should reach out to that event's organizer/club, etc. For example if you want to know things like; *Will the tournament be rescheduled? Will I get a refund for my dance ticket or raffle ticket?* These questions can only be answered by the event organizer, club or organization. One thing you can be sure of, if the event is scheduled to take place in an HOA facility between now and March 31, 2020, it is canceled.

The following is the status of Activities Office events that were scheduled through the end of April 2020, we will update you as often as we can. You will note that concerts scheduled in the Renaissance Theater are canceled through the end of April 2020. As the Director of Activities I have made the difficult decision, after talking with industry colleagues, our booking agent and some of the performers, that because performers, and others involved in these productions need time to plan travel, lodging and other event-related tasks, that it is best to take action now. This will, I believe, also give peace of mind to our ticket-buyers who will appreciate advance notice for planning. This is not an HOA-wide closure - other HOA facilities are currently closed through March 31, with large events being canceled until further notice.

Regarding any events below where we have not given specific information about refunds: This means we have not had time yet to process this event or that we are waiting for the vendor (cases like The Coyotes, Diamondbacks and Free Spirit Vacations) to communicate with us. TAD Travel has

canceled all travel at least through the month of March. Please know that we are working with urgency to address all of these issues and that our team's priority is to keep you informed. We anticipate being busier than normal the first few days of this week helping answer questions. We ask for your patience and understanding. We promise we are addressing refunds, and all the issues that we can, but it will take time.
